Hildeberto Pereira, a Portuguese-Cape Verdean striker, had his contract with Universitatea Cluj terminated after testing positive in an anti-doping test, ending his brief tenure with the Romanian club following a career marked by stints at clubs like Benfica and Vitória FC.

### India

#### Doping Epidemic Among Youth Athletes Raises Alarm in Indian Sports

In India, doping among young athletes is a growing concern, with 22 minors currently on the National Anti-Doping Agency's (NADA) list for violations, primarily involving steroids. Experts warn of severe physical, mental, and long-term health consequences for these adolescents, highlighting the role of financial incentives, easy access to banned substances, and insufficient accountability for coaches in perpetuating this alarming trend.
